The diversity in their professional backgrounds means that each chapter adopts a different perspective, with some chapters focusing on practical solutions to problems, and others exploring more general theoretical questions. The textbook-like structure places the issues in their appropriate contexts and ensures that readers see how the discussion in each chapter links with the body of law as a whole. The impact of EU competition law beyond Europe also means that this book will appeal to lawyers in the US, Australia, Canada, and other countries.
