In such case there is no breach of contract, as the court order operates to prevent the rendition of services by the officers.<sup>70</sup> An officer may be named by the court, however, to perform services rendered necessary by the receivership, his compensation being limited to the amounts earned in such capacity, and as fixed by the court.<sup>71</sup> The same rules apply in the case of bankruptcy in determining the claim of an officer to salary.<sup>7</sup> The right of an officer to salary may cease on a transfer of all the property and business of the corporation to another corporation, particularly where he enters into the service of the new company or consents to the transfer.<sup>73</sup> And where, with the consent and cooperation of an officer of a corporation, all its property and franchises are sold, so that he has no further duty to perform, any contract which he may have had with the company for salary will be deemed cancelled, although the corporation may not be dissolved.<sup>74</sup> A statute providing that no compensation shall be allowed a president for services rendered unless allowed by the stockholders, will operate to prevent compensation for services rendered in closing the corporation's busine...
