In neither case is the jurisdiction unlimited, but it is obviously much greater in the former case than in the latter, and a much different presumption is indulged in one case than in the other. For it is the constant presumption of the law, in respect to courts of general jurisdiction, that they had jurisdiction over a case in which they have assumed to act; while, in respect to courts of special or limited jurisdiction, no such presumption is indulged, but whoever claims any right or benefit under the actions of such a court must show affirmatively that it had jurisdiction. § 517.
